Three hours minimum rental will be charged. All setup and cleanup time must be a part of the charged rental time. A two-hour cleaning period is required between all rentals. Non-profit organizations must provide non-profit documentation. Non-profit and Business address will be used to determine residency. Bereavement rentals can only be made through the Recreation Office. Holidays include New Year's Day, Good Friday, Easter, Memorial Day, Independence Day, Labor Day, Thanksgiving Day, Day After Thanksgiving Day, Christmas Day. For those Holidays falling on weekends, the Holiday rate shall be used.

Alcoholic beverages may be dispensed only in strict accordance with Section 1070.02 of the City's Codified Ordinances and only if Renter has indicated at time of rental that alcohol will be served. Renter must provide adequate security in the form of one or more off-duty peace officers authorized to discharge duties in Lorain County.
