ACKNOWLEDGMENT AND WAIVER RELEASE

IN CONSIDERATION OF BEING PERMITTED TO UTILIZE THE ERIE METROBARK PARK FACILITIES, I, for myself, my spouse, legal representatives, heirs and assigns do hereby release, waive and discharge Erie MetroParks, Huron, Ohio, a political subdivision in the State of Ohio, its officers, agents and employees from all liability to me, my spouse, legal representatives, heirs and assigns from any and all loss or damage, claims or damages (including attorney's fees) resulting from my use of the Erie MetroBark Park resulting in injury to me or my dog utilizing the Erie MetroBark Park, or injury to me or my dog or property whether caused by negligence of Erie MetroParks or other persons utilizing the Erie MetroBark Park (or their respective dogs).

I FURTHER AGREE TO INDEMNIFY AND HOLD ERIE METROPARKS HARMLESS from any and all loss, liability, damage, cost or the like (including attorney's fees) brought as a result of my use of the Erie MetroBark Park or any negligence by me in my use of the Erie MetroBark Park.

I HAVE READ this waiver of liability, assumption of risk, and indemnity agreement, fully understand its terms, and understand that I am giving up substantial rights, including the right to sue. I acknowledge that by my registration I intend to have such registration and submittal be a complete and unconditional release of all liability to the greatest extent allowed by law as I have personally signed this liability, assumption of risk, and indemnity agreement.

ERIE METROBARK PARK RULES

A dog that is deemed vicious, **per Ohio Revised Code 955.22**,
May not register or use the off-leash dog park.

1. All dogs must be registered with Erie MetroParks and wearing the Erie MetroParks registration collar.
2. Users of the dog park do so at their own risk. Dog owners are responsible for any injury or damage caused by their dog (ORC 1533.181).
3. Park users must clean up after their pets.
4. Dogs in heat are not allowed (ORC 955.22B).
5. Each dog must display current license and rabies tag (ORC 955.10 and ORC 955.39).
6. Proof of distemper and parvovirus is required.
7. No puppies under 4 months old allowed because they will not have had all of their vaccinations.
8. Maximum of two dogs per handler.
9. Dogs must be leashed when entering or leaving the dog park.
10. Dogs showing aggressive behavior must be leashed and removed from the park immediately.
11. Users under 16 years of age must be accompanied by an adult when within the dog park.
12. Users are expected to report problems immediately to Erie MetroParks staff or a volunteer on duty at the park.
13. Glass containers are prohibited.
14. Dog treats are prohibited.
15. All pets other than dogs are prohibited in the dog park.
- 16 . A dog biting another dog will get one warning, second offense - collar is revoked.**
- 17. If a dog bites a visitor, the dog's membership will be revoked immediately and the dog will be barred from entering the park.**
